Auditors' Report of Financial Statements	- SASWH trained 15,172 participants in 2023, a 46% increase from 2022 Defensive Driver Training for EMS Professionals was rolled out in Saskatchewan Update on the work currently being done by the National Alliance for Safety and Health in Healthcare (NASHH) Update on Infection Prevention and Control (IPAC) initiative with home operators in Saskatchewan.  Healthcare industry statistics around injury types, causes of injuries, and OHS contraventions were also shared.  Mike Edge, Board Treasurer and Chair of the Finance Committee, provided an overview of the 2023 Auditors' Report which was prepared by MWC Professional Chartered Accountants.
